**Bleomycin**

Bleomycin may be covered under the Medicare Part B DME benefit when used with an infusion pump in the home. Coverage of bleomycin under Part D is limited to certain long-term care facilities. Medicare Part B may cover bleomycin when administered at home OR in an assisted living facility, OR an intermediate care facility for the Mentally Retarded (ICF/MR).

Bleomycin is renally excreted and the risk of pulmonary toxicity is increased in patients who are renally impaired. Because elderly patients are more likely to have decreased renal function, it is recommended to monitor renal function during receipt of Bleomycin. Dosage adjustment is necessary in patients with creatinine clearances of less than 50 ml/min.

If you request an expedited review, and sign the attached form, you certify that applying the 72 hour standard review time frame may seriously jeopardize the life or health of the member or the member's ability to regain maximum function.
