#### Oxycontin® OR Oxycodone Extended-Release Tablets

OxyContin® is no more effective than other extended-release opioids (e.g., morphine ER, fentanyl patch, methadone) in managing moderate to severe chronic pain but appears to have higher drug abuse potential. Additionally, off-label prescribing practices (e.g., dosing three or four times daily) is a growing problem that places patients at risk for drug-induced complications (e.g., sedation, CNS impairment). Methadone is recommended for use only by physicians experienced in methadone prescribing.

If you request an expedited review, and sign the attached form, you certify that applying the 72 hour standard review time frame may seriously jeopardize the life or health of the member or the member's ability to regain maximum function.
